There are three ways to register:

1. Have the officer and finance sit together to log in and register
2. Have someone log into the student's actual account, using that specific student's username and password
3. Have the student choose the "Bill Me/PO" payment option. They can input anything as a PO number (12345, abc, whatever), and it will actually complete the registration. The officer/student will then receive an email that will have the actual invoice attached AND a link to "Pay Now" by credit card. They will need to forward that email to whoever is making payment

Please feel free to forward the following registration directions:

1. Go to <https://www.taser.com/training> and click on the "Search Upcoming Classes" option
2. Either Sign Up OR Sign In for TASER Communities. If registering for the first time, there can be a 48 business approval process before getting access.
3. Once approved they'll be able to see the list of classes. (Please note, only the person logged in will be able to see either NEW or the RECERT classes only, not both)
4. Click on the "Event Name" for the course they want
5. Click on "Add to cart" in the upper right hand corner of the page
6. Choose either Credit Card OR Purchase Order
7. "Proceed to checkout" in bottom right of screen
8. Input payment information & choose "Order for these items complete"
9. Authorize scroll pop up
10. DONE!
11. Check your email for confirmation/invoice/receipt

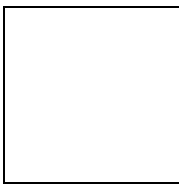
