The Washington State Fusion Center (WSFC) will be providing Fusion Liaison Officer (FLO) Basic and Intermediate training at various locations around the state from September 26 – 30, 2016:

FLO Basic

- September 27 – Lake Stevens Police Department, Lake Stevens, WA
- September 28 – WA Department of Labor and Industries, Tukwila, WA

FLO Intermediate

- September 29-30 – WA Department of Labor and Industries, Tukwila, WA

The FLO program is a statewide network of agency-selected law enforcement, fire-fighting and critical infrastructure organization representatives, which serve as integral components of the Statewide Integrated Intelligence System (SIIS) and provide the mechanism to gather and analyze information, and share actionable intelligence.

FLO classes have been approved by DHS and will be open to law enforcement, fire department and Critical Infrastructure (CI) personnel, including our Canadian partners.
