You have been selected to attend the Washington State Parks and Recreation Commission's 35-Hour Boat Operator for Search and Rescue (BOSAR) Training being held at Flagship Maritime in Tacoma, Washington. Class will start at 8 a.m. in the Flagship Maritime classroom, **821 Dock Street, Tacoma WA 98402**. Information regarding course logistics is attached.

PLEASE NOTE: If you will not be attending this course you must **NOTIFY OUR OFFICE IMMEDIATELY** at (360) 902-8846. Substitutions will not accepted **if there is a waiting list of officers who've already submitted applications and sending another officer in your place would deny others from attending.**

The course has a thirty-five hour curriculum. Attendance is required at all blocks of instruction to receive a Certificate of Completion. A prerequisite for the course is completion of the *Adventures in Boating* course or an equivalent nationally approved course. If you have already completed the *Adventures in Boating* test or an equivalent, or have your *Washington Boater Education Card*, bring proof of course completion or your card.

The attached attendee logistics sheet has details on what to bring. Uniforms are required to be worn the first day of class and during all on-water exercises. Dress for the rest of the course is casual. You must bring an agency patrol vessel for the course and **call our office at (360) 902-8846 or complete the attached Vessel List and return, to confirm your vessel will be at the course.**
